## Involvelement Opportunity Grant Fund Guidelines

1. The Involvelement Opportunity Fund will provide grants to the following schools:
  - a. Pickford Elementary School
  - b. Rudyard Elementary School
2. Each teacher may request up to \$250.00 per year. (An exception may be considered)
3. The money is to be used to provide students:
  - a. With hands-on supplemental materials for classroom use (may be consumable). Non-consumable materials become school property when no longer needed or wanted by the requesting leader. Sharing is expected when possible.
  - b. A field trip to follow up studies in the classroom or to provide an educational experience which students might not have the opportunity otherwise. Examples: Mill Creek, Cheboygan Opera House, Fort Mackinac, Sudbury or Marquette Children's Museums, Sault Lock Boat Tours, etc. The funds may be used for tickets, transportation etc. More than one class may be combined.
4. Fund may be requested throughout the year as needs arise, and funds allow.
